In accordance with the Governor's Executive Order 20-12, "Stay Home, Save Lives," the Lake County Sheriff's Office is asking residents to stay in their homes. This order is effective immediately and remains in place until lifted by the Governor.

Please leave your house only for essential activities, i.e., getting a weekly supply of groceries, picking up take-out meals, purchasing medical supplies or receiving medical care, accessing financial services, buying pet food, or getting supplies to work from home.

All non-essential gatherings are prohibited, regardless of size. Gatherings of people within the same residential household are allowed.

Playgrounds, sport courts, state parks, campgrounds, pools and other types of outdoor recreation facilities are closed.

Feel free to walk your dog, jog, or bike in your neighborhood if you can stay 6' away from other individuals.

The Lake County Sheriff's Office, Oregon State Police, and first responder's continue to respond to public safety needs.

"Your Sheriff's Office is continuing to provide the public safety and customer service you all expect and deserve. Please contact us if you need assistance. Times are evolving rapidly and we understand it causes uncertainty. We appreciate your partnership as we do our part to keep our community safe and slow the spread of COVID-19. As we always do, we will share information and seek voluntary compliance as we continue to use discretion in enforcing the spirit of the law."

PLEASE call our office at 541-947-4966 as this schedule will change, and frequently. Other trips may also become available.


The Governor's Order states we all must stay home as much as possible to discourage viral spread. Our remoteness also compromises our access to accessing urgent health care in time.

So far, Lake County has no cases of the novel coronavirus; however, some of our medical destinations have active cases. Let's all work together to keep this epidemic out of Lake County.

Celebrate Nourishment

Adapt, Create, Inspire by Crystal Coulter

During this unsettling time we may feel compelled to recall ways of the past. Here is a go to chart for weekly groceries that was given to me years ago. I believe it was crafted in 1960.

Weekly Market List	Two Adults	Two Adults & Two Children
Green leafy vegetables	6-71bs	15 lbs
Oranges, tomatoes, grapefruit	4 lbs	8 lbs
Other fruit and vegetables	8 lbs	25 lbs
Potatoes, including sweet	1 ½ - 2 lbs	13 lbs
Dried peas, beans	½ lbs	1 lbs
Milk	8-10 qts.	19 qts.
Cheese	1/2 lbs	1 lbs
Meat, include poultry and fish	5 lbs	12 lbs
Eggs	1 dozen	2 dozen
Bread, flour, and cereal	6 lbs	13 lbs
Butter	1 lbs	2 lbs
Fats and oils	1 ½ - 2 lbs	3 lbs
Sugars, syrups, molasses, jams, and jellies	2 lbs	4 lbs

Plan meals according to the items on the chart and craft your shopping list. *As your Children become adults I would suggest utilizing "Two Adults" as your purchasing guide. have a family of four so I simply double "Two Adults" to accommodate their appetite. In regards to toilet paper, the much talked about product... The Average Household of 4 that is staying home 24-7 will need 34 double rolls for a single month, according to TODAY(source).

5 Ingredient Mozzarella

Ingredients:

1 gal. Raw Milk (skim off cream)

1½ cup Vinegar

1 tsp. Unrefined Salt

Pinch Baking Soda

1 Tbsp. Grass-fed Butter

*Thermometer

Directions:

Pour milk in a pot and heat slowly to 126°, gently stir during this process. Remove from heat and add 1 cup of vinegar, stir and let sit for 1 hr. Remove the large curd while generously squeezing out the liquid, place in a bowl. Add ½ cup vinegar to the pot, mix well, set a mesh strainer over a bowl, cover with cheesecloth and pour liquid - this separates the remaining curd from the whey. Place curd in the bowl, add in 1 tsp. Salt and a good pinch of baking soda, mix with a spoon, let set ½ hr. Now add 1 Tbsp. butter. Using the double boiler method melt mixture. Once melted, pour into a flat bottomed bowl and cool overnight in the refrigerator. Enjoy

Fabric Surgical Masks Information

Thank you for your interest in sewing fabric surgical masks for healthcare personnel caring for patients.

Your time and talent can greatly impact our ability to care for our community members and help ensure our safety as we do. Fabric masks offer the benefit of being able to be washed and re-used. Still a large supply is needed, as each healthcare worker will need to change their mask several times during their shifts, as the mask becomes soiled or damp – for maximum protection.

We aren't worried about looking stylish – but we are concerned about functionality. Non-matching fabrics, thread, binding strips are just fine – but a well sewn mask with no frayed edges or missed seams or "holes" is important.

In order to make sure the masks are safe and as effective as possible, we ask that you consider the following points.


- Recommended fabric for the outer portion of the mask includes heaver, nonstretch fabric such as denim, duck cloth, canvas, twill, or other tight woven fabric.
- Recommended fabric for the inner lining and filter pocket can be other cotton, cotton-blend non-stretch fabric. It can be thinner and softer, but again recommended minimal or non-stretch.
- . Must be laundered in HOT water prior to sewing to prevent future shrinkage.
- Polyester or other less breathable fabric will not work as well, due to moisture produced when breathing.
- If using denim or other fabric that is being "recycled", please be sure it is clean and in good shape. Worn or dirty fabric will not be protective.
- Elastic should be in good shape, with plenty of stretch and of an appropriate size to fit over the ears. 1/16 inch round cord or 1/8 inch braided work best.
- If elastic is not available, fabric ties can be sewn on the mask. There will need to be 4 ties (one tie on each of the 4 corners). Ties should be approx. ¼ inch in width, sewn in such a way that there are no frayed edges, and long enough to be tied into a bow on the top of the head (for the top corner and behind the head for the bottom corner).

FABRIC SCRAPS (NEED 1 LIGHT AND 1 DARK COLOR FABRIC FOR VISIBLE CONTRAST)

SEWING MACHINE OR SERGER

13IN OF 1/4IN ELASTIC (ANY NARROW ELASTIC WORKS)



Step 1: Cut 2 of pattern A fabric right sides together, cut 2 of pattern 8 fabric right sides together. Cut 2, 6.5in pieces of 1/4in elastic.



- Step 2: Fold pattern A fabric 1/4in from end (as shown on pattern) top stitch down.
- Step 3: Fold pattern B fabric 1/2in from end (as shown on pattern) top stitch down.
- Step 4: With pattern A fabric right sides together, sew curved seam to create the center of mask with 1/4in seam allowance with a straight stitch. Clip curved seam to allow seam to lay flat.
- Step 5: With pattern B fabric right sides together, sew curved seam to create the center of the mask with 1/4in seam allowance. Clip curved seam to allow seam to lat flat.
- Step 6: Match pattern A and B at middle seam (nest seams) and stitch with 1/4in seam allowance both layers together at top and bottom (leaving ends open). Pattern A WILL BE LONGER THAN pattern B!
- Step 7: Before turning right sides out, zig-zag stitch pattern A and B edges together at the nose of the mask (2in down from top point on both sides, 4in total).
- Step 8: Slide wire between 1/4in seam allowance and zig-zagged edge at nose point, bend slightly around the curve.

Step 9: Turn mask right side out using the side openings.



CLOTH SURGICAL FACE MASK PATTERN

INSTRUCTIONS ONLY

SUPPLIES:

Fabric scraps (Need 1 light and 1 dark color fabric for visible contrast)

Sewing machine or serger

13in of 1/4in elastic (any narrow elastic works)

3in wire (thinner gauge enough to bend and hold for nose piece. Can even use paperclips! Make sure to bend ends in so the wire does not poke through fabric)

STEP 1: Cut 2 of pattern A fabric right sides together, cut 2 of pattern B fabric right sides together. Cut 2, 6.5in pieces of 1/4in elastic.

STEP 2: Fold pattern A fabric 1/4in from end (as shown on pattern) top stitch down.

STEP 3: Fold pattern B fabric 1/2in from end (as shown on pattern) top stitch down.

STEP 4: With pattern A fabric right sides together, sew curved seam to create the center of mask with 1/4in seam allowance with a straight stitch. Clip curved seam to allow seam to lay flat.

STEP 5: With pattern B fabric right sides together, sew curved seam to create the center of the mask with 1/4in seam allowance. Clip curved seam to allow seam to lat flat.

STEP 6: Match pattern A and B at middle seam (nest seams) and stitch with 1/4in seam allowance both layers together at top and bottom (leaving ends open). Pattern A WILL BE LONGER THAN pattern B!

STEP 7: Before turning right sides out, zig-zag stitch pattern A and B edges together at the nose of the mask (2in down from top point on both sides, 4in total). (See FIG. 1)

STEP 8: Slide wire between 1/4in seam allowance and zig-zagged edge at nose point, bend slightly around the curve.

ZIG-ZAG FABRIC LAYERS AT TOP OF MASK (FOR NOSE)

STEP 9: Turn mask right side out using the side openings.

**ADD WIRE BEFORE TURNING

WIRE CUT AT 3IN

STEP 10: Fold pattern A (folded edge) down to meet pattern B folded edge, top stitch pattern A 1/4in from fold to form a tube end for elastic.

STEP 11: Slide 6.5in piece of elastic through tube opening on both ends of mask (pattern A side), bring both ends of elastic together and stitch 1/4in, stitch back and forth a few times to secure the ends together using a straight stitch to reinforce elastic.

STEP 12: Tuck sewn ends of elastic through tube and YOU ARE FINISHED!!

LIBRARY TAKE OUT STARTS MARCH 31

While all Lake County Library District locations remain closed to the public to be in compliance with the Governor's Stay Home, Save Lives order, library patrons will soon be able to check items out again through a new Library Take Out service. Beginning Tuesday, March 31, 2020, library locations will have weekly pick up times that the public can use to take library items home.

There are three steps to using Library Take Out. First, library patrons must place items on hold. Patrons can do that by signing into their library account online and placing holds themselves or by calling or emailing their local library. Second, patrons should arrive at their local library's designated pick up day and time. Third, patrons should call the library to say they are outside and ready to pick up. Library staff will check the items on hold out to the patron and place the items on a table, chair, or bench outside the front door for the patron to pick up. The hold deadline is noon for same-day Take Out.

Library staff in all locations will continue to answer phones and email during each facility's normal operating hours. All returned items must be placed in the drop box for each location. Incoming items are held in quarantine for at least 3 days before reshelving and checkout to the next patron.

People who are at higher risk for severe illness

COVID-19 is a new disease and there is limited information regarding risk factors for severe disease. Based on currently available information and clinical expertise, older adults and people of any age who have serious underlying medical conditions might be at higher risk for severe illness from COVID-19.

Based upon available information to date, those at high-risk for severe illness from COVID-19 include:

People aged 65 years and older

People who live in a nursing home or long-term care facility Other high-risk conditions could include:

People with chronic lung disease or moderate to severe asthma People who have serious heart conditions

People who are immunocompromised including cancer treatment People of any age with severe obesity (body mass index [BMI] >40) or certain underlying medical conditions, particularly if not well controlled, such as those with diabetes, renal failure, or liver disease might also be at risk.

People who are pregnant should be monitored since they are known to be at risk with severe viral

illness, however, to date data on COVID-19 has not shown increased risk.

Many conditions can cause a person to be immunocompromised, including cancer treatment, smoking, bone marrow or organ transplantation, immune deficiencies, poorly controlled HIV or AIDS, and prolonged use of corticosteroids and other immune weakening medications





BACK IN THYME

CALABAR BEAN: Physostigma Venenosum Balf. Pea Family: Leguminosae

The line between a deadly poison and a beneficial drug is very fine. Exactly how fine is shown very clearly by the fruit of the twining woody vine native. To the area of Africa once known as Calabar. Here the River Niger, close to the end of it's 2,600 mile journey to the sea, has lots of streams that run like blue veins across the Niger Delta. The Calabar vine roots in the riverbanks and sends its stems climbing 50 to 60 feet high among the trees. Long clusters of it's big purple flowers hang in spring like bloated wisteria blossoms. After the flowers fall, 6 inch long, brownish-yellow seedpods develop, when they ripen they split, showing 2 or 3 fat maroon seeds called calabar beans.

Until the past century or so, the Calabar bean served the people of the region as sort of a botanical Judge, jury and executioner. Someone accused of a serious crime was given a drink made from the powdered beans. If he regurgitated the concoction, he was presumed innocent; if it killed him, he was quality. It was a simple and direct system of justice, but when the British colonized the area, they disapproved. Hoping to end the practice of trail by ordeal, they banned the cultivation of Calabar beans. The vines grew wild, however, and so the measure had little effect. By the mid 19th century they outlawed the practice altogether.

The potency of the beans remained a mystery. What poison was in them? But more important, could it be used to help rather then to kill people? In time, scientific research answered both question. The beans contain several alkaloids, the key one being physostigmine, a powerful stimulant of muscular contractions. It kills by contracting the heart, diaphragm, and pulmonary muscles to the point of rigid paralysis. Because of this property, the drug has proven useful in reversing the action of such poisonous substances as atropine and curare, which kill by relaxing the same muscles. Doctors have used physostigmine and synthetic neostigmine, to stimulate intestinal muscles after the shock of surgery and to counteract symptoms of the muscle weakening disease myasthenia gravis. Today it is used in ophthalmology: It is a meiotic, causing the pupil of the eye to contract; and to help reverse the build up of pressure inside the eye that can lead to blindness in the disease in the disease glaucoma.

Businesses Take Extra Precautions

After going into the Sagewood Market the other day I noticed the tape on the floor. Guild lines say 6 feet apart, this is exactly what they are doing. You place your items on the counter and step back to the tape, the cashier will ring you up and step back, you step forward to pay and maybe bag your items, the cashier will finish the transaction. Please don't give the employees a hard time, they are doing the job in the correct ways in order to protect both you and them. We all know that it's hard to stay home or away from our friends, and I am sure with the children being out of school this extra time they are going bonkers as well. This Virus will be gone soon and life will be back to what is normal to us all. Remember wash your hands with soap, water and sing the ABC song. . Everyone be safe and remember we will get past this all.

Many of us are working from home when at all possible, however there are some who can't. We have Caregivers who are going the extra mile to ensure that people who depend on that help are getting it. My hat is off to you. We have the EMS crew who is called out not knowing what they will walk into and yet they go go go. Our Sheriff's Department is on call for all things and are doing their very best to be everyplace all the time. The Fire Department is another department that is here to serve. All these people have family and are also taking extra precautions to be safe.
