

If you purchased "cheap land" in Lake County, and you thought that you could do anything you like on that property without consulting the Lake County planning commission, and without knowing what the zoning of that property allowed, then the answer is 'yes', you did buy into a lie.

Property ownership comes with many rights, however these rights are often superseded by local zoning ordinances and State regulations. Zoning ordinances impose restrictions on how a particular property can be used and establish requirements such as building heights and setbacks, septic requirements, types of buildings,

and uses of property. Some property owners view these ordinances as an infringement their upon constitutional right to personal property, but zoning ordinances

ensure that land is developed in a manner that protects the rights of ALL members of a community.

ordinances establish Zoning whether land shall be used for residential, commercial, agricultural or industrial uses. The ordinances also dictate the manner in which the land is developed by restricting the density, building heights, parking, setbacks and other attributes related to development.



aim of local government. Before a property owner is able to build or live on his property, he must meet all of the zoning conditions in order to receive a building permit, unless an exception called a variance is made.

Zoning decisions are not always final. If your local planning commission rules that your proposed plans do not conform to the zoning, you can file an appeal where owned, leased, or occupied in you can argue your case. You can also apply for a variance, which fines "Nuisance" as meaning "any



Lake County has a Prohibition and Abatement of Nuisance Ordinance (Ordinance No. 116) that also relates to property Lake County. This ordinance de-

> act, or condithat tion works causes injury, damage, inconvenience, annovance, or discomfort to another and legitimate

enjoyment of a person's reasonable rights of person or property, or is capable of causing an unreasonable threat to the public health, safety, and welfare under the circumstances". Number one on the list of issues addressed for abatement and enforcement is "the depositing or accumulation upon property of any junk, trash, garbage, vegetative debris, human or animal waste, vehicles, vehicle parts, or any other material which substantially detracts from the cleanliness of the area,



allows for an exception to an existing zoning law. Another option is to obtain a conditional use permit, which permits you to use the land as you propose as long as you meet special conditions. If local zoning officials continue to rule against you, you can always challenge them in court and hope a judge or jury sees things your way. This is an expensive and time-consuming route to take, but the courts are often the final arbiter as to whether zoning or private owner's prevail.

Property ownership also comes





creates a stench or fire or safety hazard which would be likely to injure any person including children". For a full copy of this ordinance and, if needed, to file a bona fide nuisance complaint visit Lake County's website.

In the Summer of 2021, the County Commissioners were taken on a tour of Christmas Valley and the surrounding areas in North Lake County to see the need for enforcing the zoning regulations and the nuisance ordinance. They were appalled at several things they witnessed in the area. Subsequently, a code enforcement position was established in Lake County and the Lake County Commissioners recognize that code enforcement is essential and is now a priority in Lake County.

Zoning in the United States began in earnest in New York City with the passage of the 1916 zoning resolution. The resolution established height and setback requirements for buildings in the city. It was a direct response to the construction of the Equity Building, which cast a seven-acre shadow over neighboring property that lowered property values. As zoning ordinances spread across the United States, they were challenged by those who felt that the ordinances were a violation of their individual rights to do what they wanted with their own property. Eventually the issue was addressed by the Supreme Court in the 1926 decision of Village of Euclid v. Ambler Realty Co. The court ruled that zoning regulations were a legitimate use of

government authority.

Oregon's statewide land use planning program was created in 1973 to conserve farm land, forest land, coastal resources, and other important natural resources; to encourage efficient development; to coordinate the planning activities of local governments and state and federal agencies; to enhance the state's economy; and to reduce the public costs that result from poorly planned development. In 1973 the Legislative Assembly passed the Oregon Land Use Act (Senate Bill 100), under that program all cities and counties adopted comprehensive plans that meet mandatory state standards. The standards are 19 statewide planning goals that deal with land use, development, housing, transportation, and conservation of natural resources. The passage of Measure 37 in November 2004 showed the potential for profound changes in the implementation of land use laws. The Legislative Assembly subsequently fashioned a compromise bill, which was passed by the voters in 2007 as Measure 49.


When cities, counties and states fail to enforce their own land use zoning ordinances the cost is borne by the public by way of their property tax dollars being spent on expensive clean up and remediation. It is much more costly for the County to have to clean up a bad land use situation, than it is to curtail it from the start; before it becomes a costly "nuisance".





When you have a utility easement on your property, the utility company/Water District may have a range of legal rights.

A few restrictions you might face include:

- Utility company/Water District access without your approval.
- Utility company/Water District may restrict your use of the easement when your use can harm underground water mains, valves, water meters, and the like.
- Restrictions on physical alterations: You may want to make an improvement to a certain section of your property. But the utility easement may prevent certain upgrades, such as erecting a fence or a gate.
- Vegetation restrictions: The utility company may require regular access to a particular area and constantly tear up your garden. Additionally, many utility easements limit the planting of major trees in a specified area.

If you're considering purchasing a property with a utility easement, take some time to research the local laws and regulations.

- Creative and persistent in following through on accomplishing identified needs.
- Public Safety telecommunication infrastructures beyond 911-PSAP in Lakeview need upgrading to effectively reach all areas across the county.

- US Forest Service on three National Forests. Primary duty: Wildlife Biologist. Also interdisciplinary duties of water rights, minerals, namely oil & gas, boundary survey, timber sale planning, etc. 14-year tenure in Oakridge, all friends were loggers, served on Search & Rescure and police reserves.
- I visited Lake County every summer, drawn by the openness and the farming & ranching values, as of my chilhood years.
- Transferred to US Bureau of Land Management to come to Lake County. Duty Station being Lakeview; retired 2006 to be commissioner and learn Lake County as home.

ACCOMPLISHMENTS AS PRIOR COMMISSIONER

Short list of things accomplished or assisted with.

- Revamped the County's Mental Health program, within first 6 months. Started with zero knowledge, but persisted to learn and accomplish the end product.
- Years representing Lake County & SE Oregon on State's Sage-grouse Habitat Committee (SageCon) and BLM's Resources Management Plan Amendment, leading to the decision not to list the grouse as endangered. Very significant for many of our ranching families, economy, and our lifestyle!
- Led efforts to form State-mandated Early Learning HUB, that addresses our economically disadvantaged youth of 0-5 years of age.
- Assisted North Lake resident in gaining local banking service in Christmas Valley.
- Assisted North Lake resident in gaining Klamath Community College (KCC) services to North Lake.
- Assisted Adel rancher John Kiely in getting BLM to remove major excess of wild horses from Beaty Butte Allotment; prime grouse habitat. Excess horses degrade habitat environment and would lead to listing of the grouse. Two-Prong Strategy; John negotiated with BLM. Conveyed such to then-Congressman Walden. Walden approached the Post Master General. The decision to close rural Post Offices was reversed.

Summer Lake still has a Post Office.

All the issues on the Commissioners' monthly agendas are important. Often major issues and/or opportunities arise beyond commissioners' agendas and need to be addressed for the greater whole.

Knowledge, adapting and persistence to achieve are critical traits; USMC!

CRITTER CORNER

Roughly five years ago, I planted two Swamp milkweed plants, a favorite of Monarch butterflies. I observed one mature Monarch frequenting the milkweed, thereafter two caterpillars. Deer kept munching the milkweed, and years since haven't seen any Monarchs.

This past spring, I transplanted the two milkweed plants to main vegetable garden that has deer-proof fence and tended the plants with adequate watering, etc. Still haven't seen a mature Monarch since five years ago. HOWEVER, on the morning of Wednesday, 7/27/2022, there are two Monarch caterpillars on the Swamp milkweed plants!!! The yellow, white, black bands are very distinct.




